**Please don't delay and ask me during the seasons. I may have covered all the events.**

**Only taking so many clients in 2020-21!**

**The 2020-21 Sports Select Client Plan** is **\$535.00 for one client and one sport** (includes taxes) up front before I start. This includes a \$75 fee for **one client per sport** and a payment of \$425 for all digitals. **(Note: I only charge \$425 per family. Call me if you are not sure how this works.** The number of images you may receive is based on the amount your athlete plays. The amount can range from 50 to as high as 1000+ photos. Last year I took in around 30 clients and I took +- **65,000** images. Yes, **65,000!** That's a lot of hours behind a computer, and like I said above, **it takes time to do things right!** The average client received about 300 edited digital photos per sport. Please remember if your son or daughter does not play a lot during an event or season I may not be able to shoot this amount. I now write all edited photos to a thumb drive. **If you have more than one athlete go ahead and fill out their information. Depending on number of clients and sports I may offer a discount if their events are at the same event or events. Example: Basketball, all games normally played together, or both play that same day and location.**

If after your event or events I have not acquired sufficient photos, I will return to another event if possible. In most cases I will be at more than one event if possible. Please note, I will not photograph all school events. The events I cover are based on a first come basis and game schedules.

**If you want prints too:** There are many ways to order, but the simplest way is to write down the **last** 5 to 8 numbers of each photo on paper, take a photo with your phone and text or email it to me. I can send you a price list if you are interested. **Remember these are your digital images, and if you print yourself you will save!**

**I will only photograph clients that have contacted me prior to a game with your athlete's info, and fees paid! No form No payment No deal.....need both**

**Please don't delay** and ask me later in the middle of the season or **during a game,** as I will be busy photographing clients who have signed my contract and paid all fees. **Remember, I may only come to 1 or 2 events, so asking me in the middle or the end of the season might be too late. If you forgot, then try and catch me before or after the game.**
